

Palomar Solar – Official Sweepstakes Rules

Palomar Solar Supports Our Local Troops

1. How to Enter. Enter online at **Palomargives.com**. No purchase necessary to enter or win. One valid entry per contestant. Palomar Solar Ltd. ("Palomar") is not responsible for lost, damaged, late, misdirected, incomplete or illegible entries, or technical problems incurred while entering via the internet. Contest entrants agree to abide by the terms of these Official Rules and by the decisions of Palomar, which are final on all matters pertaining to the contest. If unable to enter online, entrants may also mail entries to Palomar Solar Ltd., Attn: Contests, 1526 Sterling Ct, Escondido CA 92029. Mailed entries must include the contest name, specific entry period, first and last name, email address, full postal address and phone number on a single sheet of paper or postcard and are subject to the same entry period and rules as online entries.

2. Sweepstakes Period. Entries will be accepted from July 19, 2023 through September 6, 2023 (the "Sweepstakes Period"). All entries must be received by 11:59 p.m. on September 6, 2023.

3. The Prize(s).

THREE (3) finalists will be selected at random from the entered contestants and they will receive up to 4 chalet tickets to the Palomar Solar Chalet at the 2023 Miramar Air Show "Airshow" on September 22, 2023 matinee Show. Transportation to and from the Show are the responsibility of the contestant.

ONE (1) Grand Prize winner(s) will be selected at random at the "Airshow" who will receive a Palomar Solar designed PV system up to a Seven (7) Kw DC with a total estimated retail value of up to \$25,000.

- System will be designed by Palomar Solar to fit the finalist's needs. The following criteria will affect the design
 - Finalist's current KW usage will determine the system size needed. All Finalists will be required to provide current green button data from SDGE for consideration.
 - System will be a roof mount PV system, roof dimensions may limit system size. Not all homes have roof space capable of supporting up to 7kw.
 - Main service panel may limit the system size, not all main service panels can accommodate a 7kw system.
 - Palomar Solar LTD. Shall make the final determination of the system design.
 - Before each client project, Palomar makes a determination of the condition of each homeowner's roof. As contest winners are treated as standard clients, the age and condition of the roof will be accessed by Palomar before any solar installation will be initiated. If it's determined a new roof is required, Palomar will be happy to provide a bid. Use of Palomar is not required to receive the new system. ***The solar system cannot be installed on a roof in need of repair.***
